From our Pastor ...

Peace be yours dear Disciples of the Lord,

We have been serving the Shepherd together now for Five months. In that timeframe I have come to be especially fond of this part of God's family. In my service as Shepherd's Intentional Interim, I am aware that our time together will be limited. The exact amount of that time is in Christ's hands. Our task together is to listen for the mission to which Shepherd of the Hills is being called to serve in the coming years.

"Shepherd of the Hills" is the title of a delightful fictional tale from an earlier era in our country's history. As the story unfolds, the narrator makes clear that shepherding a community of people is the ministry congregations are to undertake. That is our Baptismal vocation. This call will not be the same as it was in previous decades, but it will bear all the marks of the Church's mission throughout the centuries; namely *inviting others to "Come and See" that the Lord is Good*. Our congregation is invited to invite others—some who are much like us and some who are much different from us.

The Spirit has always drawn like and unlike together to care for, love, and learn from each other. Why? So that the light of Christ will draw others into the safe harbor of Jesus' love. Forming one body from various parts is the work for which Christ's church was built.

In that regard let me put that work in the context of the Intentional part of our Interim work together. It is hoped that a congregation in transition will complete the process of grieving the past, connecting with the Interim pastor and then move toward the future and into the stage of setting a revised mission toward which they hope to move with a permanently Called-Pastor. In graphic presentation this progress looks something like this:



The descending portion of the line marks the transition from grief into new beginnings. As the line starts to ascend, the connection with the Interim is well formed. The pie-shaped mark is the beginning of the interpretation of renewed mission and enthusiasm for that mission and on into preparation for calling a new leader who is willing and able to come alongside the congregation and move with you into the next phase of ministry. Shepherd of the Hills is well on its way to being ready for renewed life. This last portion of the progression will need to be accomplished with the greatest amount of deliberate thought and action. Please hear my encouragement that we move forward thoughtfully. I would ask the congregation to keep in mind the words of the Psalmist in our reading from the 2nd Sunday after the Epiphany where it is written: ***'I waited patiently upon the LORD,... 'You are the LORD; do not withhold your compassion from me; may your steadfast love and your truth continually keep me safe.*** As was said that same Sunday, "the Lord has already identified the person to serve as the next regularly called Pastor of Shepherd of the Hills." Let's wait patiently for the revelation of the Lord's will in this regard. Praying that Rich Blessings will be yours, I remain your traveling companion.

Treasurer’s Report – President Lorie Englert presented the 2021 Financial Review and the 2022 Budget. Fiscal year 2021 was a good year, thanks to all of our members’ generosity and the second Payroll Protection Plan (PPP) loan. Thank you, Cristy and Bob, for securing the loan and obtaining subsequent forgiveness. We went from a predicted \$47,271 deficit to ending \$8,141 ahead. The Church has three distinct revenue streams, the Church itself, the Preschool and the Before & After program, all of which contributed to our positive outcome. The Church’s revenues have been great, thank you, and we have kept expenses down. Without the Preschool and B&A programs, we would have had a \$147,250 loss. Jennifer Walker has adjusted from remote Preschool to filling all three Preschool classrooms this year and netting \$6,641. Ashley Metcalf has built a solid B&A program, initially all day during remote learning, creating classrooms for the kids to attend classes and do their homework, and now, with in school attendance, back to the traditional Before & After program. The B&A program netted \$81,505 for 2021. Both programs have been a great service to the community during the last year! Between Preschool, B&A, the generosity of the congregation and the PPP loan, we were able to make a profit in 2021! The President then asked that the 2021 Financial Report be moved and seconded for approval. The details are:

The 2022 Budget was based on the last 6 months of 2021, which is how we anticipate 2022 to go, with in-person services and continuing live streams. We are proposing a \$39,862 deficit budget. We anticipate some growth in envelope giving but also higher expenses. As we replace staff that has left, we are finding the wages are increasing. We hired Nancy Sobotta to assist us with our communications and she is doing a great job extending our reach to the congregation. The office has managed expenses quite well and the budget reflects normal increases. We anticipate the Preschool and Before & After programs will do as well if not better in 2022. Thank you. Endowment Fund Report

The Endowment Fund was established in February of 1987 by generous members of our congregation. The proceeds from the Fund are only to be used for special ministries such as scholarships to Lutheran colleges and seminaries, Bible Camp scholarships, leadership training for our youth, assistance to area families in need, as well as many outreach ministries including world disasters and missions.

The endowment is not used for the general expenses of the church which are covered by the annual church budget. It is specifically to be used to provide "extras" which could not be accomplished without its support.

It is hoped that individuals or families might consider a gift to the Endowment Fund through a memorial, charitable remainder annuity trust, stock certificates, a donation of property, or remembering the Endowment Fund in a will.

The Endowment Fund provides an opportunity for people to continue supporting the ongoing ministry of the Lord even after their death. Members of the Endowment Fund Committee stand ready to visit with anyone who might be interested in contributing to this important ministry.

The committee meets quarterly to review investments and budgets and to discuss ways to share with others how they may also make gifts to this special fund. The committee makes recommendations to the Church Council which in turn gives final approval to the programs.

The committee members are: Kathy Marinangel, Carol Janssen, Jim Heard, Pam Umbarger, Bob Preston and Pastor Rob Kinnear.

Reserve Fund

The Reserve Fund serves as the Church's emergency fund and savings account. Wilbert Hecht funded this account with a generous bequest and additional funds have been added in the years since. Mr. Hecht specifically directed that the funds be used to maintain and improve the building and property. In the past, funded work has included: COVID upgrades and mitigation measures, parking lot repairs, education wing refurbishment, recording and broadcasting equipment for worship and computer network infrastructure upgrades. In 2023 we will be focusing on the exterior painting and repairs, as well as sealcoating and restriping the parking lot.

Pastor Rob was identified as a possible candidate for the position. When asked, he agreed to be our Intentional Interim. **Pastor Rob will continue to be our Pastor until we call the next Resident Pastor.**

Also, thank you to the entire staff who worked extra hard during the initial phase of the transition period. While preparing for the Interim, the staff picked up the tasks and made the decisions that we needed. Their resilience and capabilities kept the congregation humming. We have a great team supporting the ministry of Shepherd of the Hills!

The Council will be initiating the call process early this year to find a permanent pastor. Thank you for your patience during this next step in the life of Shepherd of the Hills. ~ The Church Council

Treasurer's Report

As 2022 comes to a close, and our attendance continues to increase, offerings have not reflected that increase in attendance. The country's economic uncertainty has no doubt played a factor as well. Just like 2021, we continue to broadcast to as many people as possible. We continue to offer our mobile app as an opportunity for those members who can't attend and want to give. There was good news to report as we applied for and received funds from the government ERC (Employee Retention Credit) program. Those funds totaled \$87,053. All told, Shepherd of the Hills applied for and received two Payroll Protection Program funds and the ERC fund. This certainly helped us keep our employees with us and, in turn, helped keep vital ministries going, including those benefiting both the church and outreach to members of our community. Even with the ERC credit, we still experienced a loss of \$14,541 for the year. With your continued help and generosity, we hope and pray that our financial goals will be met for 2023. Parish Education Reports

Nursery, Sunday School and Confirmation Programs

In early 2022 there were 3 children in the Nursery, Sunday School had 31 students enrolled and Confirmation had 27 students enrolled. In January 2022, the 1st and 2nd grade students and the 6th and 7th grade students received their Bibles. In April, 5 fifth graders celebrated their First Communion. Thirteen 8th graders were confirmed in May.

We made some amazing gains in enrollment this fall. More families participated in both the Nursery and Sunday School. We currently have 6 children in the Nursery, 47 students in Sunday School and 20 in our Confirmation classes. Several families had requested an 8:30 am Sunday School class so we opened that in November. We are using more of a one room schoolhouse approach for that session. Eight members are teaching Sunday School and 2 members are teaching Confirmation. A second Bible presentation was held this fall with 14 more students receiving Bibles.

We continue to use the Spark program for Sunday School along with the Family Faith Formation format during 10:00am worship, which we began last year. Children begin in the church service with their parents, sing a popular children's worship song and come forward for a children's lesson with Pastor Rob. This year, his conversations have been based on the popular novel, *The Lion, The Witch and the Wardrobe* by C.S. Lewis. (Have you noticed Aslan sitting on the pulpit?) Confirmation classes are held both Sunday mornings and Wednesday evenings.

Faith learning is lifelong. I will continue to strive, together with the families, to enhance the faith journeys of each student in our church. ~ Heather Castaing

Youth and Family Programs

This year has been busy! In January we had a Junior High School Lock-In with 15 youth in attendance. In March, 19 youth gathered to bowl in support of the Big Brother/Big Sister Foundation. We hosted our first Watch at the Cross on Maundy Thursday. On Good Friday, we put together 40 personal care kits for Lutheran World Relief. We had a successful Easter Egg Hunt with approximately 150 people in attendance. This included a train ride, face painting, balloon artist and games. 15 Key Club members from McHenry High School volunteered their time to help with the event. The church hosted 137 children for Vacation Bible School in June. High School and Junior High youth groups had laser tag and bowling events as well as volunteering at Feed My Starving Children. We collected food for FISH food pantry on 4 occasions this year. 200 children participated in our Trunk 'n' Treat Halloween party this year. Ten trunks were decorated and filled with candy. Glowby the Bubbler and DJ Kelly Hamilton entertained everyone. Twenty Junior High and High School students volunteered to run this successful event. Finally, 57 children explored the town of Bethlehem as it was in Jesus' time during our Christmas Extravaganza. Food, crafts, music and dress up were all part of the "Bethlehem market". A hot cocoa bar and walking tacos brought us back to current times! Several other Fellowship events during the year included family bonfires, trivia night, BINGO, game and crafting nights, Road Rally, participating in the Fiesta Days parade, attending the McHenry City Band, the McHenry Food Truck Off, Stade's Family Farm and the Brookfield Zoo tree trimming.

My hope for the future is to continue events that engage and excite families and that we continue to encourage people to explore their passions and gifts and to share them with our church community. ~ Heather Castaing

Before and After School/Summer Camp Program

Summer camp was a huge success this year. Our camp was full of some amazing kids! We were able to go on three bus field trips and several on site field trips. We made a lot of memories this summer!

Our B&A program had a great, but challenging, year in several ways. We started off the 2022/2023 school year by losing our Hilltop Elementary children. School District Transportation informed us they would no longer be able to bus the students from Hilltop to us. We also started off the school year walking our Edgebrook and Duker Elementary children back and forth between the schools and the church. Challenging weather was ahead. Thankfully, School District Transportation offered us the use of a van in the middle of December. It takes 3 trips but we are warm and dry!

We currently have 25 children enrolled in B&A and are hoping to continue growing! We will start registering for summer camp in the beginning of March. ~ Ashley Metcalf

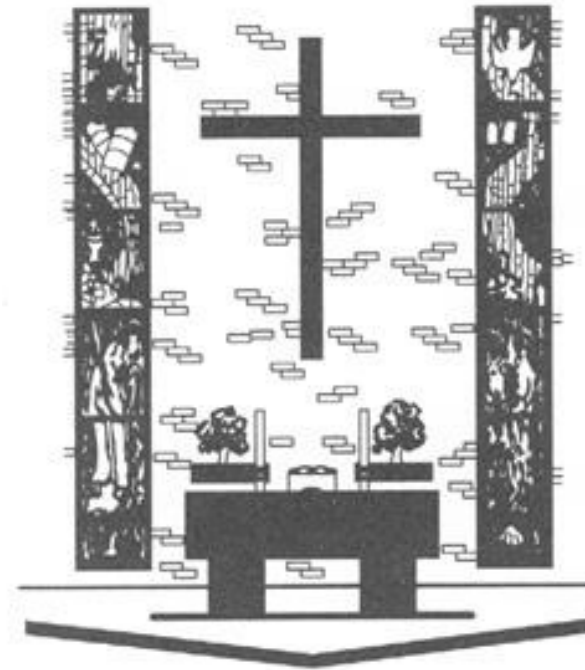
